First Communication

You will receive the first written communication on October 15th, 2018. It will include comments and observations about your child's learning and behavior.

First Report Card

The first report card will be sent home with your child on November 20th, 2018. The report card will cover the period from August 30th, 2018 to November 2nd, 2018 and will count for 20% of the student's final mark.

Second Report Card

The second report card will be sent home with your child on February 27th, 2019. The report card will cover the period from November 5th, 2018 to February 8th, 2019 and will count for 20% of the student's final mark.

Third Report Card

The third report card will be sent home to you, prior to July 15th, 2019. It will cover the period from February 12th, 2019 to June 21st, 2019 and will count for 60% of the student's final mark. The final marks for all subjects will be indicated on this report card.

Comments on Learning

For each subject, space is reserved in the report card for the teachers to provide information regarding your child's progress, strengths and challenges.

You will be notified of any significant changes made during the school year regarding evaluation of student learning. For more information on evaluation, please don't hesitate to contact your child's teacher.
